In addressing the reduction of overtime hours through operational efficiencies along with reducing the workload of our workers, we have introduced nursing care robots. We also have been proactively promoting our part time workers to full time status. We have also created an environment in which our employees can continue to work many years with job security. Along with bonus payments to our part time employees and encouragement to take paid annual leave, we have lifted the ban on dual employment as well as operating a side business.

Many assisted living/childcare workplaces employ a shifting work schedule. To create a pleasant working environment, our service facilities, receive requests for days off in advance and we make every attempt to accommodate those requests.

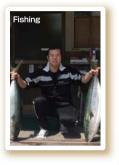
Examples of Days Off requests in addition to Paid Leave
